MILL STREET: The San Bernardino Municipal Water Department (Department) utilizes the services of on-call contractors to augment staff's ability to provide a timely response to requests for water service installations, supporting proposed development within the Department's service area. Bids are solicited from this list of preapproved on-call contractors for specific water service installation requests over the course of the following fiscal year.

The Department's Engineering section received a request from TEC Equipment at 776 W. Mill Street to install one (1) 10-inch fire service and one (1) 2-inch domestic/ 1-inch irrigation combination service. Three (3) bids were received and opened on April 2, 2025 and staff recommends that the Water Board approve the issuance of a purchase order in the amount of \$114,900.00 to Kirtley Construction, Inc. (dba TK Construction).

The funding source for this contract is Construction Orders assigned for Fiscal Year 2024/2025, No. 11088 Fire Services and No. 11091 Combination Domestic/Irrigation Services. A series of Construction Orders are generated each fiscal year to capture costs for installing typical service requests, including fire services and domestic/irrigation combination services. TEC Equipment will be issued an invoice to capture these installation fees and the water capacity charges established by Rule and Regulation No. 5. The collected installation fees will be deposited into the account for Construction Orders No. 11088 and No. 11091.

APPROVAL OF REVISION TO EXISTING POLICY NO. 51.020 -MODIFICATIONS TO PROFESSIONAL SERVICES AND COMPETITIVELY BID CONTRACTS: Policy 51.020 - Modifications to Professional Services and Competitively Bid Contracts, was revised to reflect updated procedures to contracts greater than \$250,000. The threshold for General Manager approval to change orders for these contracts was updated to \$100,000 or 5% of the original contract cost, whichever was greater. Change orders in excess of these amounts would require Water Board approval.

There was no fiscal impact associated with this revision.

E. WELL MONITORING FOR PER AND POLYFLUOROALKYL SUBSTANCES (PFAS) – NOTIFICATION LEVEL EXCEEDANCES: The California Water Resources Control Board's Division of Drinking Water Order DW 2024-002-DDW required the Department to monitor for PFAS analytes in their public drinking water system.

Under Health and Safety Code section 116455, as a retail water agency, the Department must inform its governing body and the governing body of any local agency whose jurisdiction included areas supplied with drinking water by the Department within 30 days after the Department was first informed by its analytical laboratory of an exceedance.

Samples were collected on January 23, 2025 and January 28, 2025. Three (3) samples were analyzed by the laboratory on January 23, 2025, and showed the presence of Perfluorohexanesulfonic Acid (PFHxS), a PFAS analyte, above the notification level of 3.0 nanograms per liter (ng/L). Two (2) samples collected showed the presence of Perfluorooctanoic acid (PFOA) above the notification level of 4.0 nanograms per liter (ng/L).

Two samples collected on January 28, 2025, showed the presence of PFHxS above its notification level.

#### **BACKGROUND:**

The San Bernardino Municipal Water Department (Department) utilizes the services of on-call contractors to augment staff's ability to provide a timely response to requests for water service installations, supporting proposed development within the Department's service area. Pipeline contractors are invited annually to submit their construction firms for consideration through PlanetBids. The submitted contractor qualification summaries are reviewed, and the Department approved a list of five (5) construction firms to serve as on-call contractors under Contract No. 1856 On-Call Potable Water Repair Services. Bids are solicited from this list of preapproved on-call contractors for specific water service installation requests over the course of the following fiscal year.

The Department's Engineering section received a request from TEC Equipment at 776 W. Mill Street to install one (1) 10-inch fire service and one (1) 2-inch domestic/ 1-inch irrigation combination service. Staff has elected for these requested water service installations to be performed by one of the Department's on-call contractors. Staff solicited bids from the Department's on-call contractors to perform this work. Three bids received and opened on April 2, 2025, are as follows:
