A RESOLUTION OF THE BOARD OF WATER COMMISSIONERS OF THE CITY OF SAN BERNARDINO, APPROVING THE THIRD AMENDMENT TO RESOLUTION NO.658 WITH THE WATER DEPARTMENT REGULAR PART-TIME EMPLOYEES DATED APRIL 1, 2005, AMENDING SECTION 2 – SALARIES, PARAGRAPH A SALARY SCHEDULES AND PARAGRAPH B GENERAL PROVISIONS AND ADDING EXHIBIT 6 – HOURLY SALARY SCHEDULE EFFECTIVE NOVEMBER 1, 2011.
